The Kageshwori Manohara Municipality, Office of the Municipal Executive has allocated funds towards the cost for the **Supply and delivery of fittings for pipe line of Kadaghari Drinking Water Supply Project** and intends to apply part of the funds to cover eligible payments under the contract for Supply and delivery of fittings for pipe line of Kadaghari Drinking Water Supply Project. Bidding is open to all eligible Nepalese bidders.
- 2. The Kageshwori Manohara Municipality, Office of the Municipal Executive invites Electronics Bids from eligible bidders with the following key qualifications for the Supply and delivery of fittings for pipe line of Kadaghari Drinking Water Supply Project under NCB–Single Stage Single Envelope Bidding procedures as in accordance with e-GP Procurement Directive 2074. Eligible bidders should participate in this bidding and may obtain further information and inspect the Bidding Documents through PPMO website www.bolpatra.gov.np/egp.

Key qualifications:

- a) Minimum Average Annual Construction Turnover of the last 3 years NRs. 36.00 Million (excluding VAT)
- b) Minimum Work experience of similar size and nature: The minimum supply value of goods under a single contract within the last three years should be NRs 27.10 Million excluding VAT.
