Bidding is open to all eligible Nepalese bidders.

The Kageshwori Manohara Municipality, Office of the Municipal Executive invites Electronic bids from eligible bidders with the following key qualifications for the construction as indicated in details of work below under NCB-Single Stage Two Envelope Bidding procedures as in accordance with e-GP Procurement Directive 2074.
